REBIN Business Incubator Network™ Description

The REBIN Business Incubator Network™ is a combination of a Marketing and Sales Network, a Business Incubator Network, a Cooperative Business Network and a Group Buying Network.

REBIN Business Incubator Network™ Membership Levels

There are 10 membership levels

Free Members have an Inactive Membership Status which simply means they haven't paid membership dues for the current month. All other membership levels have an Active Membership Status and a monthly fee associated with them for their membership dues. Each level comes with different benefits. Paying members (Active Members) are referred to as Clients.

Types of Network Members

REBIN Business Incubator Network[™] members can be Individuals, Businesses or Projects. (A project is effectively a strategic allinace between businesses. When two or more businesses work together to collectively offer a service, they are required to take out a separate membership to host the offering. Typically there will be a contractual relationship between the parties that are collaborating.

Vendors

A Vendor is a business member of the REBIN Business Incubator Network[™] that offers a product or service for sale through the Network. All Vendors have to give away something for free to any member who wants the free offering as part of their sales funnel.

As a member of the REBIN Business Incubator Network[™], Vendors also have access to purchase any of the products and services offered through the network.

Vendors can offer their products or services Locally, Nationally or Internationally or to specified areas.

Vendor members of the REBIN Business Incubator Network[™] are not related directly or indirectly to REBIN Group International, Inc. who is not responsible for the performance or conduct of the Vendor. REBIN Group International, Inc. is not liable for any damages either perceived or real as a result of business that is conducted by a Vendor on behalf of a member of the REBIN Business Incubator Network[™].

There are 4 classes of Vendors:

- Pre-Vendors
- Basic Vendors
- Approved Vendors
- Preferred Vendors

Pre-Vendors

If a business has not yet been created, but is in the process of collecting presales, sales commitments and doing market research, they may refer to themselves as a Pre-Vendor.

Basic Vendor

Anyone offering a product or service can list themselves as a Basic Vendor. They don't need to be an Active Member to list as a Vendor.

Approved Vendors

Approved Vendors have to be Active Members of the REBIN Business Incubator Network™. They earn this ranking based on feedback from their clients.

Preferred Vendor

Preferred Vendors are required to have a Silver membership level in the REBIN Business Incubator Network[™] or better. They earn the Preferred ranking based on feedback from their clients.

There is an application process that must be completed to earn the designation of Preferred Vendor. All Preferred Vendors have to share REBIN Group International, Inc.'s value system and comply with our Rules of Conduct and Code of Honour.

All Preferred Vendors offer something to Clients of the REBIN Business Incubator Network™ as a membership benefit that they don't offer anyone else outside the network. (This can be a product, service, bundle, a discount or alternative payment formats.)

Preferred Vendors offer Sales Commissions and Affiliate Referral Fees on most or all of their offerings.

Purchases made from Preferred Vendors can be made directly through REBIN Group International, Inc.'s payment processing systems under our brand.

Strategic Alliances

A Strategic Alliance is a special contractual relationship between REBIN Group International, Inc. and one or more select Vendors with the sole purpose of providing one or more products or services under the REBIN Group International, Inc. brand at rates or with terms that are mutually beneficial to REBIN Group International, Inc., the Vendor and the Clients.

Founders and Co-Founders

The first 100 members for each membership level are Founding Members. The next 100 members of each membership level are Co-Founders. They maintain this destinction even if they let their membership laps.

Founders and Co-Founders receive a discounts on their membership dues as long as they maintain an Active Membership Status. If they ever let their membership in a level lapse, they loose the benefit of the discont.

The discount rates are:

- 50% Discount for Founders
- 25% Discount for Co-Founders

Black List

If there are unresolved complaints or numerous complaints against any member of the REBIN Business Incubator NetworkTM, then their membership status may be 'Black Listed' which means they will be evicted from the network and won't be permitted to rejoin.

Transaction Fees

When REBIN Group International, Inc. charges for membership dues in the REBIN Business Incubator Network $^{\text{TM}}$, a transaction fee may also be applied to cover the cost of processing the transaction. It may be a function of the payment method and time required to process the payment. The amount of the transaction fee will be disclosed at the time of the payment, and is subject to change over time.

Affiliate Referral Fees

Anyone may refer a person to the REBIN Business Incubator Network™ or to its Vendors in the same way they may refer a person to any company or Vendor anywhere.

If the person making the referral is a member of the REBIN Business Incubator Network[™], they'll be recorded as the referrer of that person to the REBIN Business Incubator Network[™]. Any future purchases made by that person thereafter that generate an affiliate referral fee will cause those fees to be credited toward the referrer's account.

Affiliate Referral Fees are only paid to Active Members. There is a \$3 transaction fee to process the payment. If an Inactive Member starts generating an account balance through Affiliate Referral Fees, they will only be able to 'cash out' their account after they bring their account to an active status and pay the transaction fee. In other words, a portion of the account balance will be deducted and credited toward the membership dues and the transaction fee before the balance is paid out.

Accounts may only be paid out for balances over \$25 after the deduction for membership dues and transaction fee. Balances carry forward from month to month without penalty and they may continue to accumulate regardless of the membership status. In the event a member wishes to cancel their membership, any account balance above the \$25 will be paid out to the member. Any amount below the \$25 will be forfeited back to REBIN Group International, Inc.

Sales Commissions

The same rules for Affiliate Referral Fees apply to Sales Commissions. The one additional requirement is some products or services that offer a sales commission may have a training requirement before a member may earn the commissions.

Recruiter Commissions

Anyone may refer a business to the REBIN Business Incubator Network[™] to register as a Vendor. When they do, any time that Vendor offers an Affiliate Referral Fee or a Sales Commission, a portion of the earnings will be allocated to the recruiter who introduced the Vendor to the REBIN Business Incubator Network[™].
